Structure:

The Battle of the Bands will be held 6 - 9pm Friday, Saturday Night and 4 - 7 PM Sunday beginning on June 22nd, 23rd, 24th. Finals will be held Saturday June 30th

First round is June 22nd, 23rd, 24th (Set times and dates will be plotted by director)

Finals on June 30th - Set times are 6pm, 7pm, 8pm.

The top band each night of the first round will advance to the finals. 3 Bands each night of contest.

The Winning Band of each of the first 3 nights will perform on the finals night. The bands play in lowest to most points awarded of the first round for the finals.

Load in time will be at 5:30pm for all bands that perform that night.

All set times for 1st round and FINALS will be a 35 minute set with a 10 minute setup.

The top three positions will be awarded prizes from sponsors and overall winner will receive \$500 and the title of the Marion County Fair Battle Champion.

Eligibility:

Musical groups, duos, and solo artists performing music WITHOUT obscene or offensive lyrics, performing "live" music on stage are eligible to enter.

Registration Fee of \$25 Must be paid.

Bands must supply band name, a contact name, address, phone number, e-mail address and web address if available, as well as an alternate contact name, address, phone number, e-mail address and web address if available, style of music. SEG Productions will not accept bands with obscene or offensive lyrics, or indecent or obscene body gestures

.Bands must be dress appropriately to perform for families. Shirts and shoes required.

Submitting press kits or bios and CDs or tapes are mandatory, as part of your Registration Package. These materials will be used for media advertising purposes, marketing purposes.

RULES AND VOTING:

\$25 Entry Fee per group

All original songs and Covers are allowable in this event. We encourage covers as it is the Fair and people like to associate with the music they are listening to.

But you must have a minimum of 1 original. Judges points will be deducted if you don't have a minimum of 1 original.

All set times for 1st round and FINALS will be a 35 minute set with a and 10 minute breakdown.

Voting is taken care of in two sections.

You add the total points of section 1 and section 2 together and the top people will advance.

Section 1:

3 Judges will vote on 5 categories per Artist/Group:

Each Category is worth 10 points equaling a total of 150 points per all three judges MAX.

Section 2:

Audience Votes:

Each person that pays admission for the night will receive a voting card. Each person must vote for a 1st, 2nd, and 3rd place per ballot.

A ballot that is not filled out with all three places is a VOIDED ballot.

1st Place = 15 points per ballot

2nd Place = 10 points per ballot

3rd Place = 6 points per ballot

Finally add the total judge's point to the audience points are you have your final scores.

Under a tie, both artists will advance and time slots will be reduced for the next round they are in. (This is probably not going to happen but there is a chance)

Prizes: (Prizes will be added when MORE SPONSORS COME ABOARD.)

1st Place Winner \$500 plus prizes donated by sponsors

2nd Place Winner \$50 plus prizes donated by sponsors

3rd Place Winner \$25 plus prizes donated by sponsors
